

Foreign qualification assessment

The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Degree of Bachelor.

In general, to work as a legal practitioner in a particular country you must complete that country's required qualification. In Sweden the Degree of Master of Laws is only a formal requirement for professional practice as a judge, prosecutor and senior enforcement officer.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Facts about Degree of Bachelor of Laws (Honours)

Duration	<p>4 - 5 years</p> <p>The Honours-year is usually a 1-year extension to a 3-year Degree of Bachelor. The 5-years study programmes often consist of "double degrees", i.e. has resulted in two degrees in different subjects.</p>
Credits	<p>The country has no national credits system. However, the university may still use a credit system.</p>
Information about the qualification	<p>The qualification prepares for professional activity as a lawyer in Australia. The qualification may include a degree project and a placement. The qualification gives access to Master's- or doctoral-level programmes in Australia.</p>
National Qualifications Framework (NQF)	<p>Australian Qualifications Framework (AQF)</p> <p>The national qualifications framework (AQF) has 10 levels, where 1 is the lowest and 10 is the highest. Australia's framework has been compared to the European qualifications framework (EQF)</p>
NQF level	<p>8</p> <p>The qualification is compared to level 6 at EQF.</p>
Recognised higher education institutions	<p>Tertiary Education Quality and Standards Agency</p> <p>Please note the country can have additional recognised education institutions.</p>

The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.
