The extract indicates what a foreign qualification is comparable to in the Swedish qualification system. The information can be used when applying for a job or planning for further studies. Decisions regarding employment, admission or formal professional recognition are made by the employer, education provider or competent authority.

## About the qualification comparison

UHR's assessment reflects the number of years to which the foreign qualification is comparable at a particular level of higher education in Sweden, since the foreign qualification has no direct comparison among Swedish degrees.

The second cycle represents the second level in a three-part European structure for higher education (Bologna level 2). The figure below shows qualifications at this level.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Universitätslehrgang: Master of Science (Continuing Education Course: Master of Science)

<b>Duration</b>	<p>1 - 2 years</p> <p>There are also study programmes with a different length. The comparison will then change to the number of years that apply to the qualification.</p>
<b>ECTS</b>	<p>60 - 120 credits</p> <p>ECTS credits have been used since 2002.</p>
<b>Information about the qualification</b>	<p>The degree was introduced in 2002.</p> <p>The qualification may include a degree project and/or a placement. The qualification belongs to the sector of lifelong learning in Austria and does not provide access to doctoral-level programmes. Admission to the study programme requires a previous degree or extensive work experience.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">The National Qualifications Framework in Austria</a></p> <p>The national qualifications framework has 8 levels, where 1 is the lowest and 8 is the highest.</p>

<b>Recognised higher education institutions</b>	<p><a href="#">Federal Ministry Republic of Austria</a></p> <p><a href="#">University College for Teacher Education (Pädagogische Hochschule)</a></p> <p>There are four types of colleges in the Austrian higher education sector: (Universität (University), Fachhochschule (University of Applied Science), Pädagogische Hochschule (University college of Teacher education) and Privatuniversität (Private university)). A transition between university types often requires supplementary studies.</p> <p>Please note the country can have additional recognised education institutions.</p>

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.
