## About the qualification comparison

UHR assesses the foreign qualification as comparable to a vocational qualification at upper secondary level in Sweden. The qualification prepares for work in a specific occupation. The occupational title is indicated on the educational documents.

The foreign qualification does not give access to higher education in Sweden. For information about other ways of meeting the higher education entry requirements, please see Studera.nu.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Abschlusszeugnis der Berufsschule (Vocational School at Upper Secondary Level)

**Duration**

2 - 4 years

The qualification is based on 10 years of schooling.

**Information about the qualification**

The qualification prepares for work in a specific occupational field.

**National Qualifications Framework (NQF)**[Deutscher Qualifikationsrahmen \(DQR\)](#)

The national qualifications framework (DQR) has 8 levels, where 1 is the lowest and 8 is the highest.

**NQF level**

The qualification is included in DQF 3 and 4 depending on the professional title. Please see the DQR website for more information.

**EQF level**

The qualification is included in EQF 3 or EQF 4 depending on the professional title.

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.



Not all qualifications are included in the figure.

\*Please note that the Advanced Higher Vocational Education Diploma is included in EQF och SeQF level 6, but not in Bologna level 1.

- Bologna Framework – Qualifications Framework for the European Higher Education Area (QF- EHEA)
