## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Degree of Master.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Mesterfokozat (Degree of Master)

<b>Duration</b>	<p>1 - 2 years</p> <p>There are also combined vocational education and training degrees in some professions (doctor of medicine, dentist, pharmacist, law, architect) that requires 5 - 6 years of study.</p>
<b>Credits</b>	60 - 120 kredit (national credit system)
<b>ECTS</b>	<p>60 - 120 credits</p> <p>ECTS have been used since 2003. Combined study programmes comprise 300 - 360 ECTS.</p>
<b>Information about the qualification</b>	<p>The qualification was introduced in 2006.</p> <p>The qualification includes a degree project and may include a placement. The qualification gives access to doctoral-level programmes in Hungary.</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Hungarian Qualifications Framework (HuQF)</a></p> <p>The national qualifications framework (HuQF) has 8 levels, where 1 is the lowest and 8 is the highest.</p>
<b>NQF level</b>	7 (HuQF)
<b>EQF level</b>	7
<b>Bologna level</b>	2
<b>Recognised higher education institutions</b>	<p><a href="#">Recognised higher education institutions in Hungary</a></p> <p>Please note the country can have additional recognised education institutions.</p>

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes.
