About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Upper Secondary Diploma. The qualification is vocationally oriented.

The foreign qualification gives access to higher education in Sweden. Additional general and specific entry requirements may apply.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

Duration	4 years The qualification is based on 12 years of schooling. The elementary school begins at the age of four.
Information about the qualification	The qualification is vocationally oriented and has different specialisations. It also gives access to higher education study.
National Qualifications Framework (NQF)	Dutch Qualifications Framework (NLQF) The national qualifications framework (NLQF) has 8 levels, where 1 is the lowest and 8 is the highest.

The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes.
