## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Higher Vocational Education Diploma.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

Decisions on assigned levels in national qualifications frameworks (NQF) are made by the country in which the qualification is awarded. Our assessment does not mean that we have assigned a Swedish level for the foreign qualification.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Świadectwo Ukończenia Szkoły Policealnej (Post-Secondary School Completion Certificate)

**Duration**

1 - 2,5 years

**Information about the qualification**

The qualification is a post-secondary vocational qualification that prepares for work in a specific occupational field. After the training, the student takes a vocational examination which for programmes started in 2019 and later is mandatory to obtain the certificate of completion. After passing the vocational examination, certyfikat kwalifikacji zawodowej (vocational qualification certificate) is awarded, as well as dyplom zawodowy (vocational diploma) for a specific vocational qualification. The most common vocational qualifications from post-secondary vocational education are placed at level 4 or 5 in the PQF and EQF.

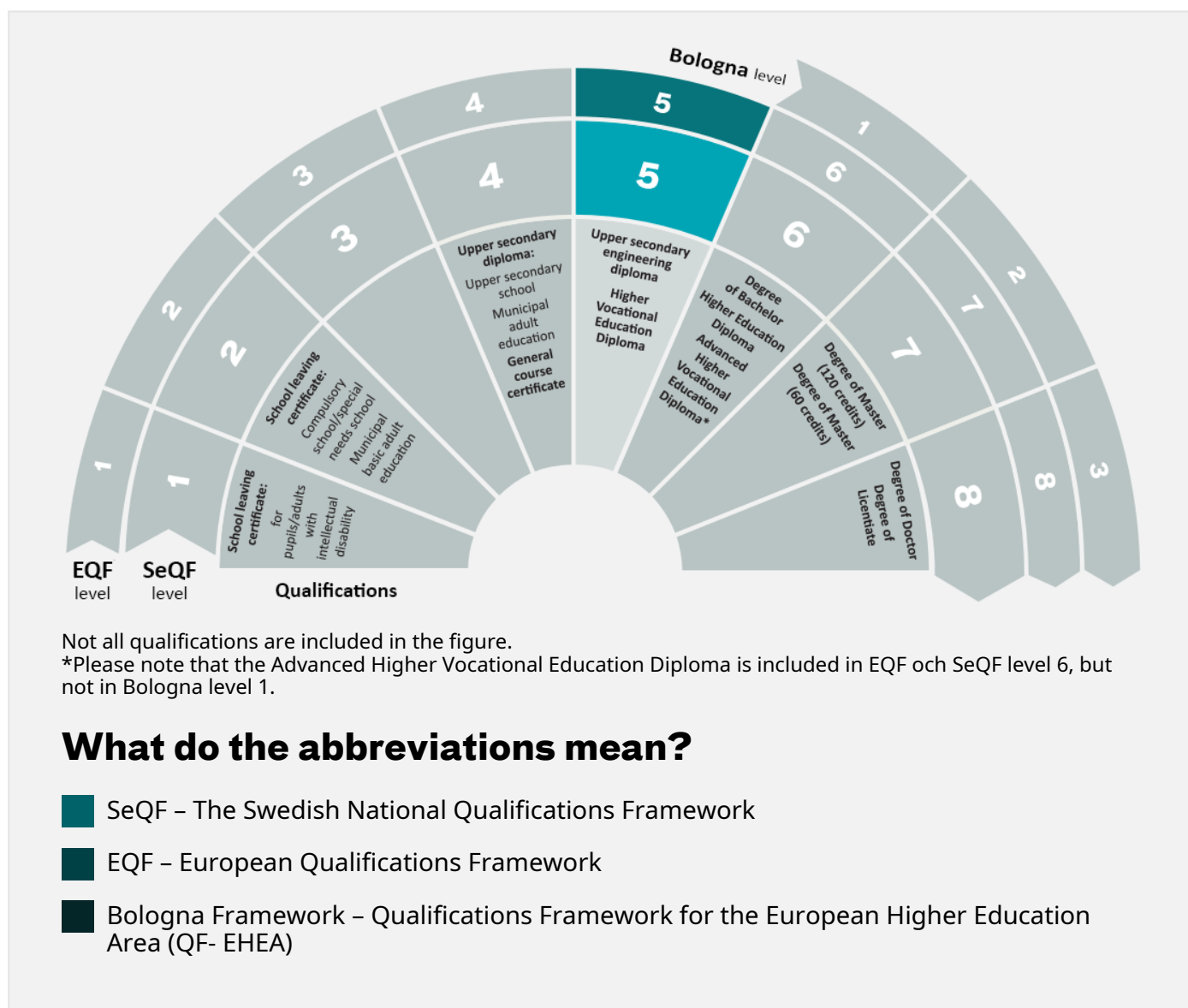
**National Qualifications Framework (NQF)**

The national qualifications framework (PQF) has 8 levels, where 1 is the lowest and 8 is the highest.

## The level of Swedish qualifications and degrees

Swedish degrees and final grades are placed within reference frameworks that show different levels of learning outcomes. In the figure, the Swedish reference framework SeQF is shown as well as the European reference frameworks that facilitate comparison to other countries. Please note the figure does not contain all Swedish qualifications.
