## About the qualification comparison

UHR assesses the foreign qualification as comparable to a Swedish Higher Vocational Education Diploma.

The figure below shows the assigned level of the Swedish qualification in the Swedish National Qualifications Framework (SeQF) and how it relates to the European qualifications frameworks.

This assessment is provided as guidance by UHR. It is based on our knowledge of the country's education system and not on the individual's education documents. UHR applies the principles of the international recognition convention Lisbon Recognition Convention and assumes the foreign qualification is recognised in the country of study.

## Facts about Certificat de Calificare Profesională Nivel 5 (Level 5 Professional Qualification Certificate)

<b>Duration</b>	1 - 3 years
<b>Information about the qualification</b>	<p>The qualification is a post-secondary vocational qualification in Romania. The qualification may have different specialisations. Programmes are provided by post-secondary schools (Școli Postliceale) and end with a Certificat de Calificare Profesională Nivel 5. Post-secondary vocational education has undergone various reforms in the recent years and previous names for the final diploma have been: Certificat de Calificare Nivel 5 (Level 5 Qualification Certificate), Certificat de Competențe Profesionale (Certificate of Professional Competence), Certificat de Absolvire a Școlii Postliceale (Post-secondary School Graduation Certificate) and Diploma de Absolvire a Școlii Postliceale de Specialitate (Speciality Post-Secondary School Graduation Degree).</p>
<b>National Qualifications Framework (NQF)</b>	<p><a href="#">Romanian Qualifications Framework (ROQF)</a></p> <p>The national qualifications framework (ROQF) has 8 levels, where 1 is the lowest and 8 is the highest.</p>

## The level of Swedish qualifications and degrees
